



## Roots 20th Anniversary Car Giveaway Terms and Conditions.

1. **Eligibility:** This competition is open to all residents of South Africa who are Royalty Rewards members, except for directors, members, partners, employees, service providers, agents, consultants of Roots Buying Group (Pty) Ltd or its affiliates, and their immediate family members, business partners, or associates.
2. **Identification Requirement:** Participants must possess a valid South African ID with a green bar-coded ID.
3. **Competition Period:** The competition runs from 27 April 2024 to 30 November 2024.
4. **Entry Requirements:** To qualify, participants must purchase at least two products featured in the Royalty Rewards monthly specials during the competition period.
